※ Notice

1. Since this application will be decoded by machines, please be careful not to rip or damage this sheet.
2. If there are errors on this application, you may not receive important information related to political parties and candidates or the ballot. Please be careful to write legibly and check the information you have written.
3. No ballots will be sent to fraudulent applications or for those who have not self-elected to register for their vote. According to Article 247 of public election laws, those found guilty can be sentenced up to 3 years of incarceration or a maximum (KRW)₩ 5,000,000 fine.

※ Instructions

1. Your name should be written as it appears on your passport.
 - ☞ However, in cases where the name on the family relation register differs from the name in the passport, write the name that appears on your family relation register.
2. For Overseas Electorate Classification, you must check the box to indicate if you had a domestic residential registration or the box that indicates if you have never had a domestic residential registration. For the former, you must write the domestic resident registration number you once had. For the latter, please indicate your birth date, (yr, mo, dy), and mark a check by your gender.
3. The purpose of obtaining family information is especially for those who have never had a domestic residential registration. We seek to verify their place of origin and the family relation register. Thus such person must write their mother and father's names.
4. In the Family Relation Register category, those who once had a domestic residential registration should mark the box indicating so, and write the last address they lived in when they were in Korea. For those who have never had a domestic residential registration, they should check the corresponding box and indicate their place of origin as indicated by the family relation register.
5. For home/work and cell phone numbers, please write the contact information at which you can be reached in the country you are currently residing. Please include the country code, the area code and then your phone number.
 - ☞ Your phone number will be used to contact you regarding election information including checking requirements, ballot information, reception of postage materials, place and duration of the vote, among other things.
6. Your email address will be used to communicate and disseminate materials produced by the National Election Commission, information regarding political parties and candidates, information regarding polling locations and dates, notification regarding registration onto the electoral register, directions and results of this application, and other relevant materials and notifications. In order to receive these things, you must write your email address.
7. You must write your current address in the country of residence carefully within the lines to receive mailings in accordance to the directions written below.
 - In the area denoted as "Required", please write your address and country of residence in roman characters or English
 - In the area denoted as "Optional", please include your address and country of residence in the official language of the country in order to increase the ease of delivery by your local postal office. Please indicate the name you use to receive mail and the family name or an attention line if used.
 - ☞ For those whose mailing addresses are unstable due to work, moving or business, or for those whose postage is affected by the conditions of the country of residence, you may use a public institution, such as the consulate, as your mailing address. In this case, please check the box noting that you are using a public institution's address and please write the name of the public institution in the address box.
8. In the area denoted as polling location preference, please write the name of the public institution that you prefer as a polling location.
9. You must include your passport and recognized official documents verifying your nationality, or documentation confirming your dual citizenship. Also, please check the relevant box indicating which documents you are submitting. When submitting documents not specified by the current categories, you must write the name of the document in the area indicated as miscellaneous.
 - ① Recognized documents verifying nationality (Issued by the country of residence)
 - ☞ Any one of the following documents indicating nationality issued by the country of residence: visa, immigration documents, long-term residency documentation or other foreign residence certificates.
 - ☞ Please see <http://ok.nec.go.kr> to look at the types of documentation accepted by country or residence.
 - ② Documentation regarding dual citizenship (Your dual citizenship must be officially recognized, and documentation must be issued by the Republic of Korea)
 - ☞ Instead of the documents indicated above ①, you may use the acquisition of nationality certificate, foreign nationality renunciation certificate, retaining nationality certificate, the nationality choice certificate, the foreign nationality abandonment confirmation document, or documentation proving military service to verify dual citizenship.
 - ☞ Attached documents should clearly show the contents of your documents and clearly show your picture, signature and date. The copies must be clean and letter-sized. When submitting the application, original documents must be shown or the application will not be accepted.
10. Towards the end, where it says "Applicant", please write your name, and sign it or include your seal.
