RESOLVES as follows:

- 1. For strengthening electoral democracy worldwide, the Electoral Management Body (EMB) of each country and election-related regional and international organizations present at the AAEA General Assembly meeting held in Seoul in 2011, agreed on the necessity for and expressed the intention to establish a Working Group to conduct a feasibility study and network with all EMBs, election-related regional and international organizations and multi-lateral agencies towards the founding of an association of world election bodies.
- 2. The interim name of this association is to be referred to as A-WEB (Association of the World Election Bodies) until such time that an official name is formally recognized through the efforts of the aforesaid Working Group.
- 3. The vision, role, organizational structure, timelines and workplan of the A-WEB are to be recommended by the Working Group after due

deliberations.

It is our hope that the EMBs of each country of the world, election-related regional and international organizations, and multi-lateral agencies will work together for the establishment of the A-WEB, and will actively cooperate in the constitution and subsequent activities of the Working Group.
